- Stable includes a small straw bed & water - please bring your own water bucket;
- Please bring your own hay & feed - this cannot be purchased on site;
- Please bring your own mucking out tools (barrows/brushes/forks);
- Stables must be **COMPLETELY** mucked out after use;
- If you wish REC Staff to muck out your stable after use, the charge will be £10 per stable – Please tick the appropriate box on the attached booking form;
- There is no availability for Hook-up, (Parking, Quiet Generators & Camping is allowed – Free of charge);
- Please observe our **Fire, Health & Safety Policies & Livery Yard Rules** on arrival – On the notice board;
